Following various general and bariatric surgery positions in Pennsylvania and Illinois, Dr. Nagalla found his home in West Texas in 2013, working in Odessa, Texas.

Dr. Nagalla is certified by the American Board of Surgery and is a member of the American College of Surgeons and other industry associations.
