PURPOSE: On behalf of Reeves County Hospital District, the Reeves County Hospital District Board of Directors will discuss and take possible action regarding an order concerning a proposed form of property tax abatement between the Hospital District and Energy Forge One LLC , pursuant to Chapter 312 of the Texas Tax Code.

Property Owner and Applicant for Tax Abatement: Energy Forge One LLC ,

Previously Established Reeves County Reinvestment Zone: Energy Forge One Reinvestment Zone (Established November 24, 2025)

Anticipated Improvements:

Energy Forge One LLC proposes to construct a new power generation facility that would utilize gas turbines to produce dedicated power to prospective data center end users and/or other power intensive end users (collectively referred to as the "Project") within Energy Forge One Reinvestment Zone.

Estimated Cost of the Improvements: The estimate of capital investment of all such improvements subject to the requested tax abatement is \$6 billion

Property in Proposed Reinvestment Zone: See attached map and legal description provided in Exhibit "A" attached hereto and incorporated herein for all purposes.


